## Return Integration Project 4

### WHAT IT OFFERS

- **departure support:** guidance interviews, collection of travel documentation, purchase of tickets, assistance at the airport of departure (Rome or Milan)
- **pre-departure allowance:** € 400 per person at the moment of departure
- **definition of individual reintegration plan:** together with the beneficiary according to a personalised approach
- **assistance for reintegration** with the guidance of the project operators in the country of repatriation
- **reintegration subsidy in goods and services:** € 2,000 for each individual or family head, € 1,000 for every dependent family member of age and € 600 for every dependant minor
- **monitoring and assistance for six months** in the implementation of the Individual Reintegration Plan
